

PRIVACY POLICY — CastNym

This Privacy Policy explains how **CastNym** (“**we**,” “**us**,” or “**our**”) handles personal information collected through our **pre-reveal website and waitlist**.

It applies only to this public site, not to any future products or features.

If we later introduce new functionality or collect additional types of data, we’ll update this Policy and provide notice.

1. Information We Collect Now

(a) Contact Information — name, email, and any optional details you provide (such as company or role).

(b) Usage Data — limited technical data like IP address, browser type, device information, and pages viewed, collected via basic analytics tools.

(c) Cookies — only minimal cookies needed for site functionality and privacy-friendly analytics. We do not use advertising or tracking cookies.

What we do not collect at this stage:

We are **not** collecting or processing any biometric, facial, or other identity-verification data.

If that changes later, we’ll first request **explicit consent** and update this Policy before any such processing begins.

2. How We Use Information

- To operate the website and manage the waitlist.
- To send you limited updates or invitations.
- To analyze overall site performance (aggregate, privacy-friendly analytics only).
- To comply with legal or regulatory obligations.

Our legal bases (where applicable) are your **consent** (for email updates and cookies) and our **legitimate interests** (for basic site operation and security).

3. How We Share Information

We may share information only with:

- **Service providers** that host our website, send emails, or provide analytics (under confidentiality agreements).
- **Legal authorities** if required by law or to protect rights and safety.

We do **not** sell or rent personal data.

4. International Data Handling

Data may be processed in the United States or other locations where our service providers operate.

We apply reasonable safeguards to protect your data consistent with applicable privacy laws.

5. Retention

We keep data only as long as needed to operate the waitlist and Site, or as required by law.

If you ask us to remove you from the waitlist or delete your data, email privacy@castnym.com and we'll remove it within a reasonable timeframe.

6. Your Choices and Rights

- **Unsubscribe / Delete your data:** send us an email at privacy@castnym.com and we'll remove you from our list.
- **Access / Correction requests:** email us to request a copy or correction of your data.
- **Cookies:** you can block or clear cookies in your browser.

Applicable laws (e.g., GDPR, CCPA) may grant additional rights, and we will honor those as required.

7. Security

We use reasonable administrative, technical, and physical safeguards to protect your data. No system is perfectly secure; use the Site at your own discretion.

8. Children

This Site is not directed to individuals under 18, and we do not knowingly collect data from minors.

If we learn that a minor has provided information, we'll delete it promptly.
